Re: Reimbursement Guidelines for Essure

Dear IEHP Provider:

Inland Empire Health Plan (IEHP) is pleased to announce a new covered benefit for IEHP Members. Essure is a permanent sterilization procedure for women and is covered by IEHP since May 1, 2010. Please review the following Essure criteria, system coding and billing instruction.

- 1) Verify IEHP eligibility on every patient prior to rendering services.
- 2) Authorization is not required for Essure.
- 3) Reimbursement is restricted to once-in-a-lifetime bilateral placement or twice-in-a-lifetime unilateral placement of the Essure System, same recipient, any provider. Claims submitted without required documentation will be denied.
- 4) Code 58565 is subject to all federal and state sterilization policy. Recipients must be 21 years of age or older.
- 5) A *Consent Form* (PM 330) is always required, even when the procedure is not successful. Must be signed 30 days prior to the surgery.
- 6) Submit your CMS 1500 with the correct CPT code with proper modifiers to IEHP Claims Dept., P.O. Box 10129, San Bernardino, CA 92423:

Physicians (Professional fee) must bill using the following CPT code + modifier

*For IEHP Direct Physicians, you may submit CPT 58565 with up to 4 modifiers on the same claim form.

Outpatient Facility

The Physician only receives their professional fee which is determined by whether bilateral or unilateral placement was achieved. The facility receives the reimbursement for the kit and supplies.


