Reminder: Diabetic Blood Glucose Testing Supplies

Dear IEHP Provider,

As a reminder, IEHP has updated access to diabetic blood glucose testing supplies by adding OneTouch products to the pharmacy benefit for our Medicare and Medi-Cal members. The Pharmacy benefits for Medi-Cal members **only** will be effective through **March 31, 2021** as they will be part of the Medi-Cal Rx transition beginning April 1, 2021. Any IEHP network pharmacy may bill IEHP for formulary diabetic blood glucose testing monitors and supplies if the prescriber sends a valid prescription following IEHP coverage criteria.

To assist you and your patients, IEHP recommends the following:

- If your patient is new to diabetic blood glucose monitoring:
 - Prescribe formulary OneTouch Verio or OneTouch Ultra meter, test strips, lancets, and control solution.
 - Provide a copy of the attached free meter voucher for your patient to obtain the meter for free from the pharmacy of their choice.
- If your patient is continuing diabetic blood glucose monitoring:
 - Consider patient-specific factors and risks and discuss appropriate treatment options with your patients before switching from non-formulary products to formulary OneTouch diabetic testing supplies.
 - Provide a copy of the attached free meter voucher for your patient to obtain the meter for free from the pharmacy of their choice
