## Reminder: Specialty Cuffs for Blood Pressure Monitors

Dear IEHP Provider,

As a reminder, IEHP has expanded access to home blood pressure monitors by adding additional products to the pharmacy benefit for our Medicare and Medi-Cal members. The Pharmacy benefits for Medi-Cal members **only** will be effective through **March 31, 2021** as they will be part of the Medi-Cal Rx transition beginning April 1, 2021. Any IEHP network pharmacy may bill IEHP for formulary blood pressure monitors if the prescriber sends in a valid prescription following IEHP coverage criteria.

Cuff Sizes:

- **Normal Sizes** (Small, Medium, Large) are a covered Pharmacy benefit.
- **Specialty Sizes** (Extra-Small and Extra-Large) are a Medical benefit and require a referral to the Utilization Management Department. Referrals should be submitted through the IEHP Provider Portal.
