- **A new modern and clean look for our Provider Portal**

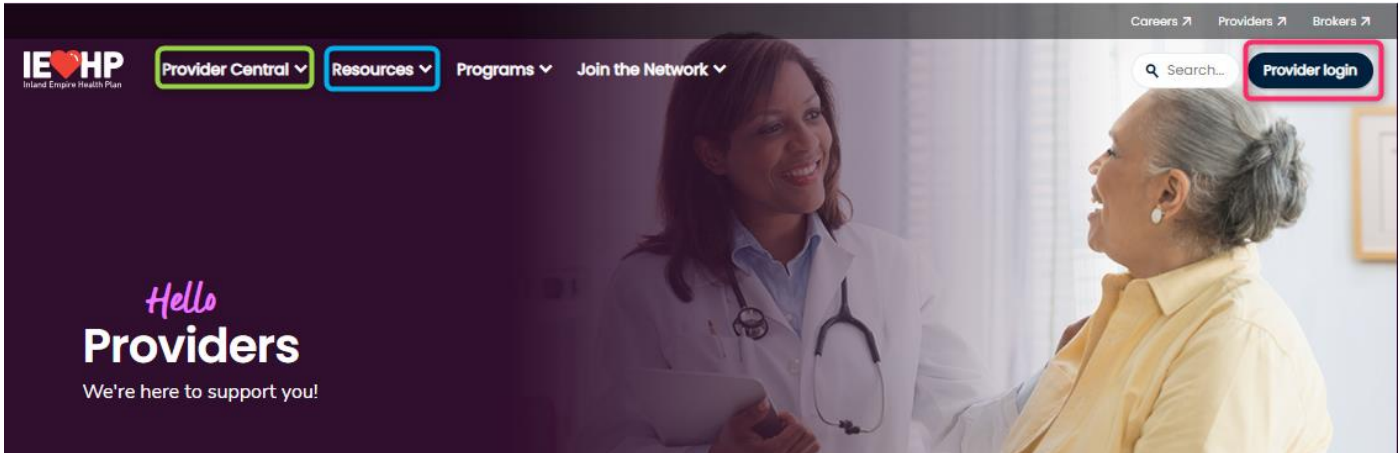
